PADA menjalankan kuasa yang diberikan oleh subseksyen 4(1) Akta Lembaga Pembiayaan Perumahan Sektor Awam 2015 [*Akta 767*], Menteri membuat perintah yang berikut:

Nama

1. Perintah ini bolehlah dinamakan **Perintah Lembaga Pembiayaan Perumahan Sektor Awam (Tarikh Peletakhakan) 2015**.

Tarikh peletakhakan

2. Menteri menetapkan 1 Januari 2016 sebagai tarikh peletakhakan bagi maksud seksyen 4 Akta dan pada tarikh itu semua harta, hak, kepentingan, obligasi dan liabiliti Kerajaan yang berhubungan dengan pentadbiran pinjaman di bawah Akta Kumpulan Wang Pinjaman Perumahan 1971 [*Akta 42*] sebagaimana yang dinyatakan dalam Jadual, hendaklah dipindahkan kepada dan terletak hak pada Lembaga tanpa apa-apa pemindahhakan, penyerahhakan atau pemindahan.

PUBLIC SECTOR HOME FINANCING BOARD ACT 2015

PUBLIC SECTOR HOME FINANCING BOARD (VESTING DATE) ORDER 2015

IN exercise of the powers conferred by subsection 4(1) of the Public Sector Home Financing Board Act 2015 [*Act 767*], the Minister makes the following order:

Citation

1. This order may be cited as the **Public Sector Home Financing Board (Vesting Date) Order 2015**.

Vesting date

2. The Minister appoints 1 January 2016 as the vesting date for the purposes of section 4 of the Act and on such date all properties, rights, interests, obligations and liabilities of the Government relating to the administration of loan under the Housing Loans Fund Act 1971 [*Act 42*] as specified in the Schedule, shall be transferred to and vested in the Board without any conveyance, assignment or transfer.
